

## PATH MASTERS OF THE TOWN OF CAROLINE

### AFTER 1923

This is a copy of a notebook in the Town of Caroline Historical Room that lists the Path Master, a description of the route he was in charge of, and the names of people who lived or owned property bordering the road in his jurisdiction. Current names of roads are in *(italic)*.

#1 – JOHN DUSENBERRY – “I do hereby appoint you as path master of the following roads: Beginning at the north line in the Town of Caroline by John Dusenberry’s small barn, thence running south to the intersection with the macadam road at Slaterville Springs, *(Midline Road from the Town of Dryden line south to NYS Rt. 79/Slaterville Road)* to remove snow from highway according to the highway law section 78-79-80-81 of the Highway Law of 1923. You are to receive \$2.00 a day for your service. You are to warn each man out to help you except those who are past seventy years of age, old soldiers, cripples, ministers, or those physically disabled. Each man is assessed a pole tax of \$1.50 a year. Each man is assessed at the rate of \$1.50 a thousand according to his assessed valuation.”

#2 – DELBERT MARTIN – “I do hereby appoint you as path master of the following roads: beginning at the north line of the Town of Caroline thence running south to the intersection of the macadam road *(Ellis Hollow Road [formerly Ringwood Road] at the Town of Dryden line south to NYS Rt. 79/Slaterville Road)* to remove snow from highway according to the highway law section 78-79-80-81 of the Highway Law of 1923. You are to receive \$2.00 a day for your service. You are to warn each man out to help you except those who are past seventy years of age, old soldiers, cripples, ministers, or those physically disabled. Each man is assessed a pole tax of \$1.50 a year. Each man is assessed at the rate of \$1.50 a thousand according to his assessed valuation.”

#3 – CHAS. THOMAS – “I do hereby appoint you as path master of the following roads: beginning at the north line of the Town of Caroline, running thence south to the intersection at Quick Cemetary[sic.] at Brookton *(Thomas Road from Town of Dryden line ,across NYS*

*Rt. 79/Slaterville Road, south on Lounsberry [formerly Mill Road] to the Landon Road intersection at Quick Cemetery) to remove snow from highway according to the highway law section 78-79-80-81 of the Highway Law of 1923. You are to receive \$2.00 a day for your service. You are to warn each man out to help you except those who are past seventy years of age, old soldiers, cripples, ministers, or those physically disabled. Each man is assessed a pole tax of \$1.50 a year. Each man is assessed at the rate of \$1.50 a thousand according to his assessed valuation."*

#4 – J. R. BULL – "I do hereby appoint you as path master of the following roads: beginning at the town line thence south to intersection at Bull's Corner and beginning on Dur. Bull's east line running thence east to the intersection at Bowne Mulks Corner (*south on Snyder Hill Road from the Town of Dryden line, to NYS Rt. 79/Slaterville Road then east to the intersection of Lounsberry [formerly Mill Road] and Thomas Road*) to remove snow from highway according to the highway law section 78-79-80-81 of the Highway Law of 1923. You are to receive \$2.00 a day for your service. You are to warn each man out to help you except those who are past seventy years of age, old soldiers, cripples, ministers, or those physically disabled. Each man is assessed a pole tax of \$1.50 a year. Each man is assessed at the rate of \$1.50 a thousand according to his assessed valuation."

#5 – D. B. BULL – "I do hereby appoint you as path master of the following roads: beginning at your east line running west to Besemer station and; beginning at town of Dryden south line on the Heath Road to the intersection at D. B. Bull corner (*Landon Road [formerly Bouton Road] intersection with NYS Rt. 79/Slaterville Road, west on State Highway to intersection with Besemer Road [formerly Hutchinson Road; starting at the Town of Dryden line on Besemer Hill Road, then east on State Highway to Landon Road intersection]*) to remove snow from highway according to the highway law section 78-79-80-81 of the Highway Law of 1923. You are to receive \$2.00 a day for your service. You are to warn each man out to help you except those who are past seventy years of age, old soldiers, cripples, ministers, or those physically disabled. Each man is assessed a pole tax of \$1.50 a year. Each man is assessed at the rate of \$1.50 a thousand according to his assessed valuation."

#6 – WM. REYNOLD – "I do hereby appoint you as path master of the following roads: beginning at the intersection of the public highway at Besemer Station running south to intersection of the State Highway on Brookton Road; beginning at the Rail Road Station going

west about forty rods to Town of Dryden Line (*south on Besemer Road from to Brooktondale Road; west on NYS Rt. 79/Slaterville Road to Town of Dryden line*) to remove snow from highway according to the highway law section 78-79-80-81 of the Highway Law of 1923. You are to receive \$2.00 a day for your service. You are to warn each man out to help you except those who are past seventy years of age, old soldiers, cripples, ministers, or those physically disabled. Each man is assessed a pole tax of \$1.50 a year. Each man is assessed at the rate of \$1.50 a thousand according to his assessed valuation."

#7 – HAROLD QUICK – "I do hereby appoint you as path master of the following roads: beginning at the intersection of the Quick Cemetery running north-west to intersection of State Highway at D. B. Bulls Cor.; Beginning at intersection at A. Landon Corner, running thence south to intersection at A. Kenyon Corner, (*Landon Road at Lounsbery Road intersection to intersection of NYS Rt. 79/Slaterville Road; Van deMark Road south-down the hill to Brooktondale Road*) to remove snow from highway according to the highway law section 78-79-80-81 of the Highway Law of 1923. You are to receive \$2.00 a day for your service. You are to warn each man out to help you except those who are past seventy years of age, old soldiers, cripples, ministers, or those physically disabled. Each man is assessed a pole tax of \$1.50 a year. Each man is assessed at the rate of \$1.50 a thousand according to his assessed valuation."

#8 – HERSHEL SCHUTT – "I do hereby appoint you as path master of the following roads: beginning at the intersection or four corners "Mulks' Corner" of the Slaterville State Highway running east to intersection of the state highway at Slaterville springs known as the Page Corner, (*NYS Rt. 79/Slaterville Road at the intersection of Lounsbery and Thomas Roads east through the hamlet to the Harford Road intersection*) to remove snow from highway according to the highway law section 78-79-80-81 of the Highway Law of 1923. You are to receive \$2.00 a day for your service. You are to warn each man out to help you except those who are past seventy years of age, old soldiers, cripples, ministers, or those physically disabled. Each man is assessed a pole tax of \$1.50 a year. Each man is assessed at the rate of \$1.50 a thousand according to his assessed valuation."

You are to receive \$2.00 a day for your service. You are to warn each man out to help you except those who are past seventy years of age, old soldiers, cripples, ministers, or those physically disabled. Each man is assessed a pole tax of \$1.50 a year. Each man is assessed at the rate of \$1.50 a thousand according to his assessed valuation.”

You are to receive \$2.00 a day for your service. You are to warn each man out to help you except those who are past seventy years of age, old soldiers, cripples, ministers, or those physically disabled. Each man is assessed a pole tax of \$1.50 a year. Each man is assessed at the rate of \$1.50 a thousand according to his assessed valuation.”

You are to receive \$2.00 a day for your service. You are to warn each man out to help you except those who are past seventy years of age, old soldiers, cripples, ministers, or those physically disabled. Each man is assessed a pole tax of \$1.50 a year. Each man is assessed at the rate of \$1.50 a thousand according to his assessed valuation.”

Each man is assessed a pole tax of \$1.50 a year. Each man is assessed at the rate of \$1.50 a thousand according to his assessed valuation.”

Middaughs, (*Valley Road from Burns Road intersection west to creek then left on Valley Road – formerly Depot Road -- to gravel bank; Perkins Road at Caroline Depot Road intersection north to Beaver Creek Road*) to remove snow from highway according to the highway law section 78-79-80-81 of the Highway Law of 1923. You are to receive \$2.00 a day for your service. You are to warn each man out to help you except those who are past seventy years of age, old soldiers, cripples, ministers, or those physically disabled. Each man is assessed a pole tax of \$1.50 a year. Each man is assessed at the rate of \$1.50 a thousand according to his assessed valuation.”

Each man is assessed a pole tax of \$1.50 a year. Each man is assessed at the rate of \$1.50 a thousand according to his assessed valuation."

You are to receive \$2.00 a day for your service. You are to warn each man out to help you except those who are past seventy years of age, old soldiers, cripples, ministers, or those physically disabled. Each man is assessed a pole tax of \$1.50 a year. Each man is assessed at the rate of \$1.50 a thousand according to his assessed valuation."
